Shipping

Vancity Community Investment Bank - Prepaid Visa will ship your order to the address provided on the order form unless otherwise specified upon receipt of payment. Please **allow up to 7 business days from funds receipt by us for your order to be fulfilled.** Address cannot be a PO Box. Canadian business addresses only. **There must be someone to receive the cards upon delivery or they could be sent back to us and destroyed.**

Custom Message

For certain programs you have the option of placing a custom message using text on the bottom of the card. The first line of text allows up to 21 characters, including spaces (19 characters, including spaces for Jeans, Skyline, and Digital Cards); the second line of text allows up to 16 characters, including spaces (14 characters, including spaces for Jeans, Skyline, and Digital Cards), as the last 5 characters of this line must be used to indicate the dollar value of the card. For any custom messaging, please allow an additional 3 business days for your order to be fulfilled. An example of a custom message is shown below.



Payment

Vancity Community Investment Bank - Prepaid Visa only accepts payment in Canadian Funds. Should a wire payment come from another country, a \$15-\$20 Foreign Funds Transfer Handling Charge may be deducted by the processing bank and the Purchaser will be responsible for covering the fee. **Orders will not be processed until full payment has been received.** Please note that company cheques, certified cheques and bank drafts may be subject to a holding period of 10 business days for funds to clear. Cheques should be made payable to Vancity Community Investment Bank Prepaid Visa.

Important Cardholder Information

All cards issued with this order agreement are non-refundable. The cards are activated and ready for use at the time they are issued to the purchaser unless otherwise indicated.
